(hereinafter referred to as the Licensor) on the one hand and the **Institute of Electrodynamics of the NAS Of Ukraine** in the person of the **director of the academician of NAS of Ukraine Kyrylenko O.V.** acting on the basis of the Charter (hereinafter referred to as the Licensee), have entered into this agreement as follows:

**1. The subject of the contract**

The Licensor grants the Licensee a non-exclusive license to use the written work free of charge. (scientific, technical) \_\_\_\_\_ (hereinafter – the Work), (title of the work) set out in \_\_\_\_\_ language, under the conditions specified in this Agreement. (language of the work)

**2. Ways of using the Work**

2.1. The Licensor grants the Licensee the right to use the Work in the following ways:

2.1.1. Use the Work by publishing it in the journal "Technical Electrodynamics" (hereinafter – the Edition) in \_\_\_\_\_ language (specify the language of presentation) (agreed by the Licensee and the Licensor copy of the Work accepted for printing is an integral part of the License Agreement).

2.1.2. Rework, adapt or otherwise modify the Work in agreement with the Licensor.

2.1.3. Translate the Work in the case when the Work is presented in a language other than the language intended for publication in the Publication, as well as in the language of other countries for its distribution in accordance with paragraph 2.1.7.

2.1.4. Make copies of the Work when reproducing the Edition.

2.1.5. Distribute the Work together with the Publication on a gratuitous basis in accordance with the relevant by the order of the Presidium of the NAS of Ukraine and the requirements of the legislation on distribution of control and obligatory copies of the Publication.

2.1.6. Make copies of the Work in case of additional reproduction of the Edition in paper and electronic form.

2.1.7. Distribute the Work on the territory of Ukraine and other countries by:

– subscription, sale and free transfer of the Publication where the Work is published, including copies of the Work in electronic form and their translations;

– providing access to the Work on the Internet;

– inclusion of the Work as an integral part of collections, databases, etc .;

– in agreement with the Licensor - publications of the Work in other, including foreign, publications.

2.2. The Licensor grants the Licensee the right to issue a sublicense to the publishing organization for the methods of use of the Work specified in paragraph 2.1.

2.3. The Licensor grants the Licensee the right to provide in the sublicense of the publishing organization the right of such organization to enter into sublicense agreements with third parties, which are necessary for the implementation of the methods specified in paragraph 2.1 of use.

2.4. If the publication of the Work in foreign publications or the use of the Work in other ways specified in paragraph 2.1, provides for payment to the Licensor of the relevant fee, the Licensee and the Licensor enter into an additional agreement to this Agreement for its payment.

2.5. The work in the scientific journal "Technical Electrodynamics", posted on the journal's website in electronic form, is used under the terms of the **Creative Commons license "Attribution-NonCommercial-NoDerivs": CC BY-NC-ND.**

### **3. Territory and term of use**

The Licensor grants the Licensee the right to use the Work in the ways specified in paragraph 2.1 of this Agreement on the territory of Ukraine and other countries during the term of copyright to the Work.

### **4. Disclaimer Licensor states that:**

- he is the author (co-author) of the Work;
- copyright to this Work has not been transferred to another publisher;
- this Work has not been previously published and will not be published in any other publication before its publication by the Licensee;
- he has the right to grant permission (license) to use the Work under this Agreement, if the Work was created in connection with the performance of an employment contract;
- he did not violate the intellectual property rights of others. If the Works contain materials of other persons, except in cases of citation to the extent justified by the scientific, informational or critical nature of the Work, the use of such materials is carried out by the Licensor in compliance with the law.

### **5. Other conditions**

5.1. The Agreement is valid from the date of its signing and is concluded for the term of copyright to the Work.

5.2. Licensor in accordance with the Law of Ukraine "On Personal Data Protection" agrees to the Licensee to process it and provide third parties with their personal data for the purpose of concluding and implementing this agreement and the Licensee's obligations under applicable law Licensor confirms that notified (without additional written notice) on the rights established by the Law of Ukraine "On Personal Data Protection", their content is clear.
